

### **FOSFA International list of banned previous cargoes**

The FOSFA Council has endorsed the Oils and Fats and Technical Committees' recommendation that Spent Bleaching Earth Oil (SBEO) and its derivatives are to be added to the FOSFA List of Banned Immediate Previous Cargoes. The considerable potential to contain contaminants removed from the edible oil during processing as well as its uncertain nature because of possible blending with other waste oils such as POME oil, EFB oil and UCO, SBEO and its derivatives will be added to the FOSFA List of Banned Immediate previous cargoes with the implementation date to be effective from 1 September 2024.
