FOSFA introduces optional clause on EU Deforestation Regulation (EUDR)

The EU Deforestation Regulation (EUDR) will have a significant impact on certain commodities that are imported into EU member states.

FOSFA thoroughly assessed the implications of this regulation on their contracts. After careful consideration, the following Optional EUDR Clause for FOSFA Contracts is introduced:

"FOSFA INTERNATIONAL – EUDR

This clause shall be applicable to Goods placed on the EU market on or after 30 December 2024. The Goods must adhere to Commission Regulation (EU) 2023/1115 or any subsequent regulations within the existing legal framework."

This clause will be included in the Optional and Special Clauses list.
