AGM and Annual Dinner 24 April 2014:

The Council, during their meeting of 12 September, has decided to set the 96th Annual General Meeting and Annual Dinner of NOFOTA for Thursday 24th April 2014. Like other years, the event will be hosted by Maison van den Boer in the Hulstkamp Building in Rotterdam. More information will follow in the December circular letter.

NOFOTA 100-years in 2018 and Centennial Book:

In 2018 NOFOTA will celebrate her 100th anniversary. Although this looks quite far away the Council is already taking preparations.
